- 5) We understand that we are required to have a current, active membership with HSLDA.
- 6) We understand that our responsibilities as parents are as follows:
 - a. Parents are required to keep the following records and report to the school
 - i. Report Card for grades (K-8)
 - ii. Record of Attendance
 - iii. Course of Study
 - iv. Health and Immunization Record or Waiver
 - b. Statement of Teacher Qualifications are due upon entrance to the school
 - c. Parents will provide and pay for their own curriculum
 - d. Failure to turn in required paperwork by the date due will result in automatic termination from the school and forfeiture of our registration fee.
- 7) We have read the school's Statement of Faith and agree that this is not only the basis of the school, but also the standard of our home.
- 8) We understand that we are responsible for our student's safety and conduct.
- 9) We understand that if we withdraw our student, we must notify the school immediately.

Olive Branch Christian Academy operates on a nondiscriminatory basis, with equal treatment and access to services as required by law and Christian principles. We are a Christian organization and do not receive nor apply for government funding.

Statement of Faith

What we believe and teach...

1. About God

God eternally existed in three persons: the Father, the Son, and the Holy Spirit. These three are coequal and are one God. Genesis 1:1, 26,27; 3:22; Psalm 90:2; Matthew 28:19; 1 Peter 1:2; II Corinthians 12:14.

2. About Man

Man is made in the spiritual image of God, to be like Him in character. He is the supreme object of God's creation. Although man has tremendous potential for good, he is marred by an attitude of disobedience toward God called "sin." This attitude separates man from God. Genesis 1:27; Psalms 8:3-6; Isaiah 53:6, Romans 3:23; Isaiah 59:1,2.

3. About Eternity

Man was created to exist forever. He will either exist eternally separated from God by sin or in union with God through forgiveness and salvation. To be eternally separated from God is Hell. To be eternally in union with Him is eternal life in Heaven. Heaven and Hell are places of eternal existence. John 3:16; I John 2:25; 5:11-13; Romans 6:23; Revelation 20:15; Matthew 18:8 and 25: 44,46.

4. About Jesus Christ

Jesus lived a sinless human life and offered Himself as the perfect sacrifice for the sins of all men by dying on a cross. He arose from the dead after three days to demonstrate His power over sin and death. He ascended to Heaven's glory and will return again to Earth to reign as King of Kings and Lord of Lords. Matthew 1:22,23; Isaiah 9:6; John 1:1-5,14; 10-30; Hebrews 4:14,15; 1 Corinthians 15:3,4; Romans 1:3,4; Acts 1:9-11; I Timothy 6:14,15; Titus 2: 13.

5. About Salvation

Salvation is a gift from God to man. Man can never make up for his sin by self-improvement or good works. Only by trusting in Jesus Christ as God's offer of forgiveness can man be saved from sin's penalty. Eternal life begins the moment one receives Jesus Christ into his life by faith. Romans 6:3; Ephesians 2:8,9; John 1:12; 14:6; Titus 3:5; Galatians 3:26; Romans 5:1.

6. About Eternal Security

Because God gives man eternal life through Jesus Christ, the believer is secure in that salvation for eternity. The grace and power of God that gives this security maintain salvation. John 10:28,29; II Timothy 1:12; Hebrews 7:25; 10:10,14; 1 Peter 1:3-5.

7. About the Holy Spirit

The Holy Spirit is coequal with the Father and the Son as God. He is present in the world to make men aware of their need for Jesus Christ. He also lives in every Christian from the moment of salvation. He provides the Christian with power for living, understanding of spiritual truth, and guidance in doing what is right. The Christian seeks to live under His control daily. II Corinthians 3:17; John 16:7-13;14:16,17; Acts 1:8; 1 Corinthians 2:12, 3:16; Ephesians 1:13; 5:18; Galatians 5:25.

8. About the Bible

The Bible is God's Word to all men. Human authors, under the supernatural guidance of the Holy Spirit wrote it. It is the supreme source of truth for Christian beliefs and living. Because God inspires it, it is truth without any mixture of error. II Timothy 3:16; II Peter 1:20,21; II Timothy 1:13; Psalm 119:10, 12:6; Proverbs 30:5.
